Description:

Human trafficking is a transnational threat and remains a serious issue for Belarus. Official government statistics indicates a steady, but gradually rising number of identified trafficking survivors over the past few years - 381 VoTs were identified in 2023, 210 - in 2022, 244 - in 2021.

IOM counter-trafficking action in Belarus is aimed at supporting the efforts of the Government of Belarus to prevent and combat human trafficking; minimize its negative social implications for the victims of human trafficking. A central pillar of the IOM C-TIP operations is improving the system of identification and strengthening of the national referral mechanism (NRM) in protecting and providing assistance to the victims of human trafficking, building capacities of respective governmental bodies and public associations, and enhancing cooperation among all the parties concerned.

In 2023, IOM Belarus as a key non-governmental direct assistance service provider identified 101, against 97 VoTs identified in 2022 and 74 – in 2021. Facts of labor exploitation and involvement in sexual exploitation of Belarusian adults and, increasingly, children continue to dominate.

In addition to that, there has been a recent spike in cases of sexual exploitation of children, in particular the involvement of children in the production of pornographic material. According to IOM statistics, the percentage of children involved in sexual exploitation out of the total number of victims was 14.1% in 2021, 37.83% in 2022, and 40.4% in 2023.

Given the above, IOM will organize 6 in-person trainings on tackling sexual exploitation of children, in particular, the involvement of children in the production of pornographic material, through proactive identification and provision of reintegration and rehabilitation support in 6 regions of Belarus with a view to enhancing the quality of protection services available to a vulnerable group of children by the pre-school education system of Belarus.

Core functions / responsibilities:

- ✓ To improve knowledge and expertise of the participants on the issues of sexual exploitation of children, including identification, referral of potential child victims of trafficking, their rehabilitation and sustainable reintegration;
- ✓ To share best practices in child sexual exploitation identification, referral and sustainable reintegration;
- ✓ Improve the participants' skills in providing targeted phyco-social assistance to child VoTs and potential VoTs;
- ✓ Provide a networking platform for the participants to share experience in the issue;
- ✓ To elaborate ideas how to facilitate enhanced cooperation among the preschool education sector and other NRM stakeholders in the sphere of tackling sexual exploitation of children, in particular the involvement of children in the production of pornographic material;
- ✓ Any other objectives in line with the training concept as might be proposed by the consultant.

Required Qualifications and Experience:

- ✓ Higher education in the field of psychological or social sciences;
- ✓ Knowledge of the national and international legislation in combatting trafficking in human beings;
- ✓ At least ten years of professional experience in the sphere of combatting trafficking in human beings;
- ✓ Proven experience in developing training modules and agendas for facilitating group work;
- ✓ Proven experience in moderating trainings and/or workshops over the past 10 years that involve the use of interactive training methods;
- ✓ Advanced communication as well as public speaking skills;
- ✓ Advanced level of knowledge of written and spoken Russian;
- ✓ Ability to conduct the capacity building event and fulfill the requirements described in the Terms of Reference.
